6.1. Replication Charter Update (Action)

A discussion was had related to selecting a name for a possible second campus. Although adding a second K-5 campus is among the ideas being explored and not the final decision related to Anser expansion, it was noted that it was difficult to write a possible charter or charter revisions during the summer if a name had not been selected. There was discussion on having more community input on the process. It was pointed out that the members of the current Anser community would not be attending a replication school, if opened, making it the responsibility of the board of directors to select the name. Barry Human made a motion to approve Trek as the name of the possible second campus based on the naming protocol completed by a group of board members, parents, and teachers. AnnMarie seconded the motion. The motion was approved with a 7/1 vote with a dissenting vote from Staci Shaw.
